



# Fig.1 Grounded Emitter Propagation Characteristics


Fig.2 Typical Output Characteristics



COLLECTOR TO EMITTER VOLTAGE :  $V_{CE}$  [V]


## Fig.3 DC Current Gain vs. Collector Current(I)

Fig.4 DC Current Gain vs. Collector Current(II)



## Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current(II)




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current







Fig.8 Gain Bandwidth Product vs. Emitter Current


