The 74AHCT08 provides provides four independent 2-input AND gates with standard push-pull outputs. The device is designed for operation with a power supply range of 4.5V to 5.5V.


The gates perform the Boolean function:









Voltage Waveform Propagation Delay Times Inverting and Non Inverting Outputs


Figure 1 Load Circuit and Voltage Waveforms

- D. t_{PLH} and t_{PHL} are the same as t_{PD} .







Package Outline Dimensions (All dimensions in mm.)





Suggested Pad Layout


