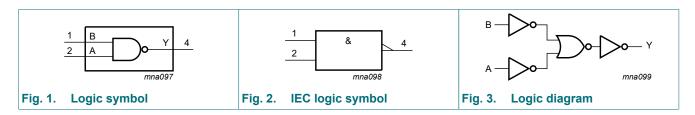

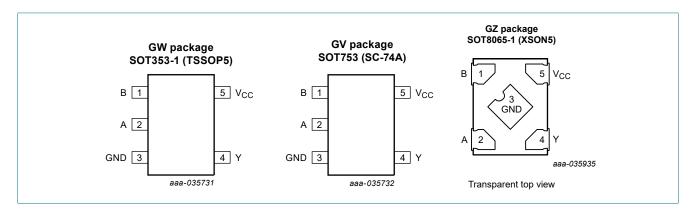

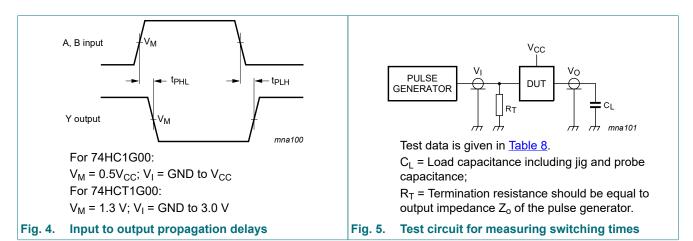

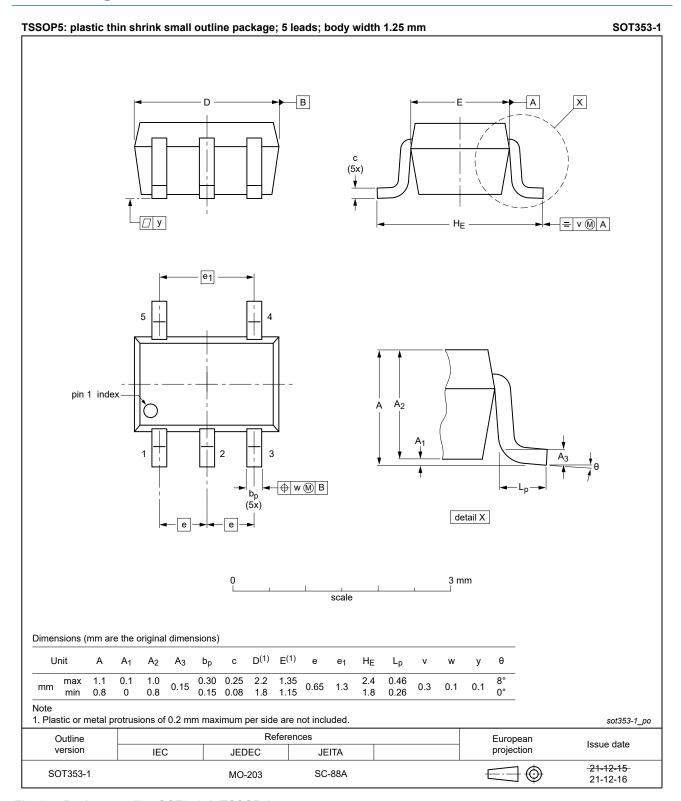


Fig. 6. Package outline SOT353-1 (TSSOP5)

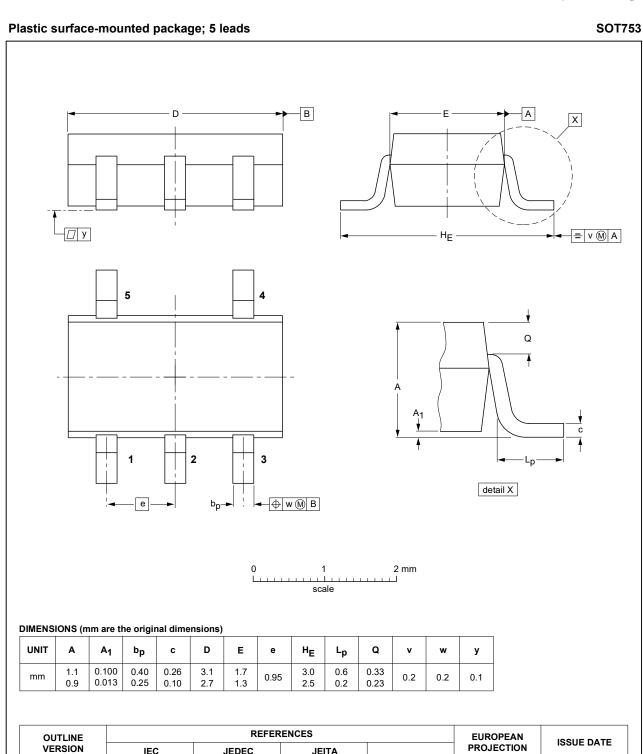


Fig. 7. Package outline SOT753 (SC-74A)

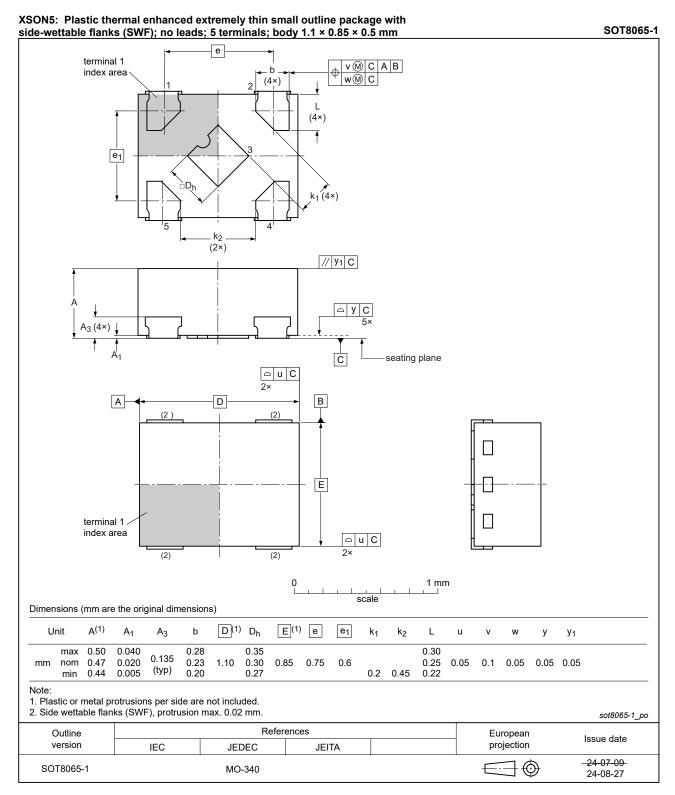


Fig. 8. Package outline SOT8065-1 (XSON5)
