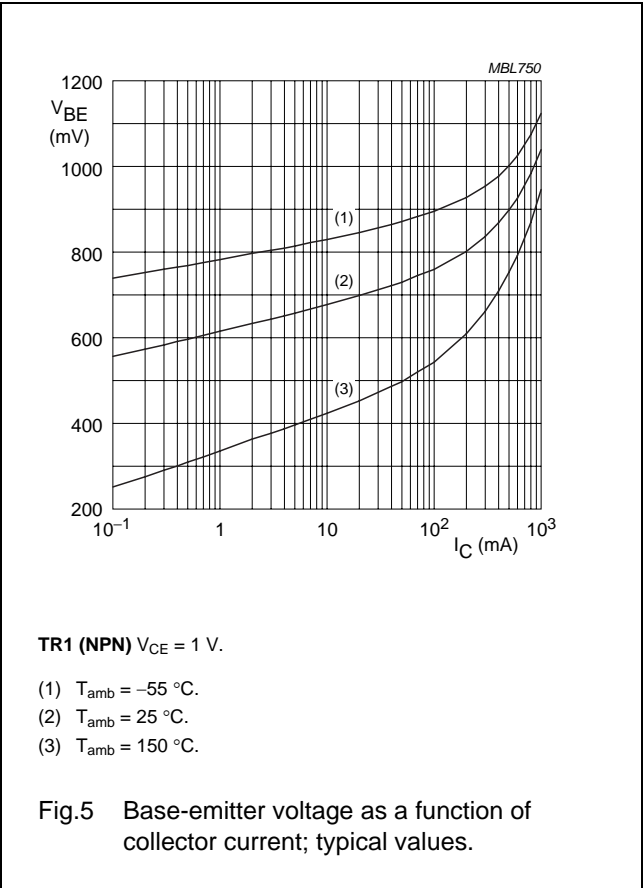

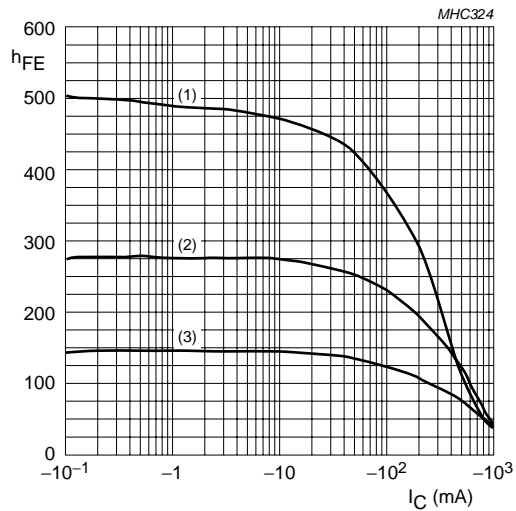

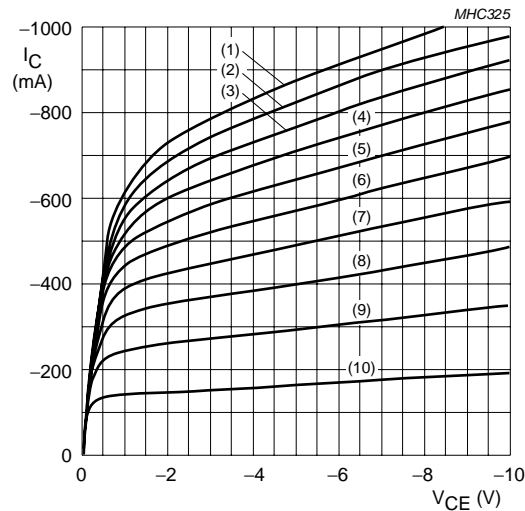

Fig.6 DC current gain as a function of collector current; typical values.



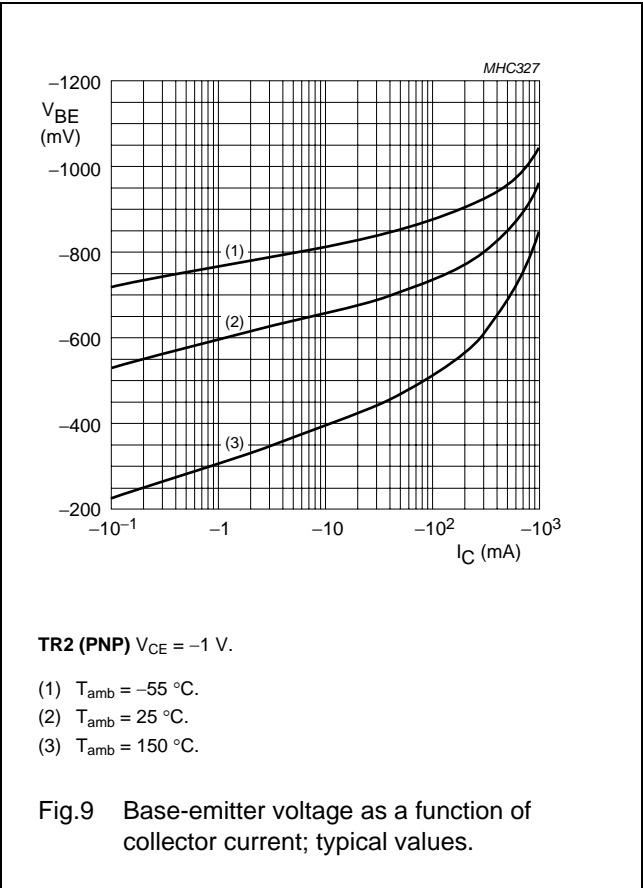
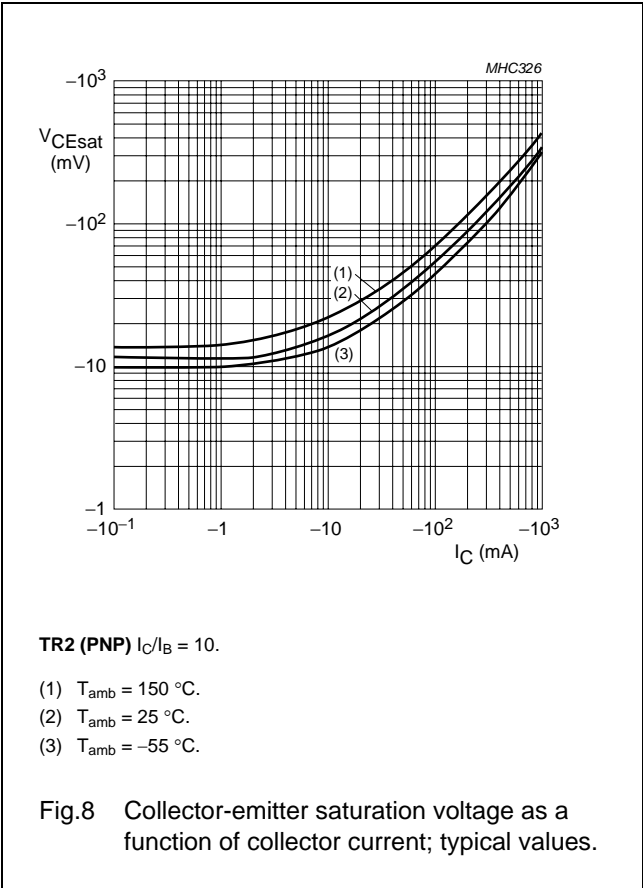

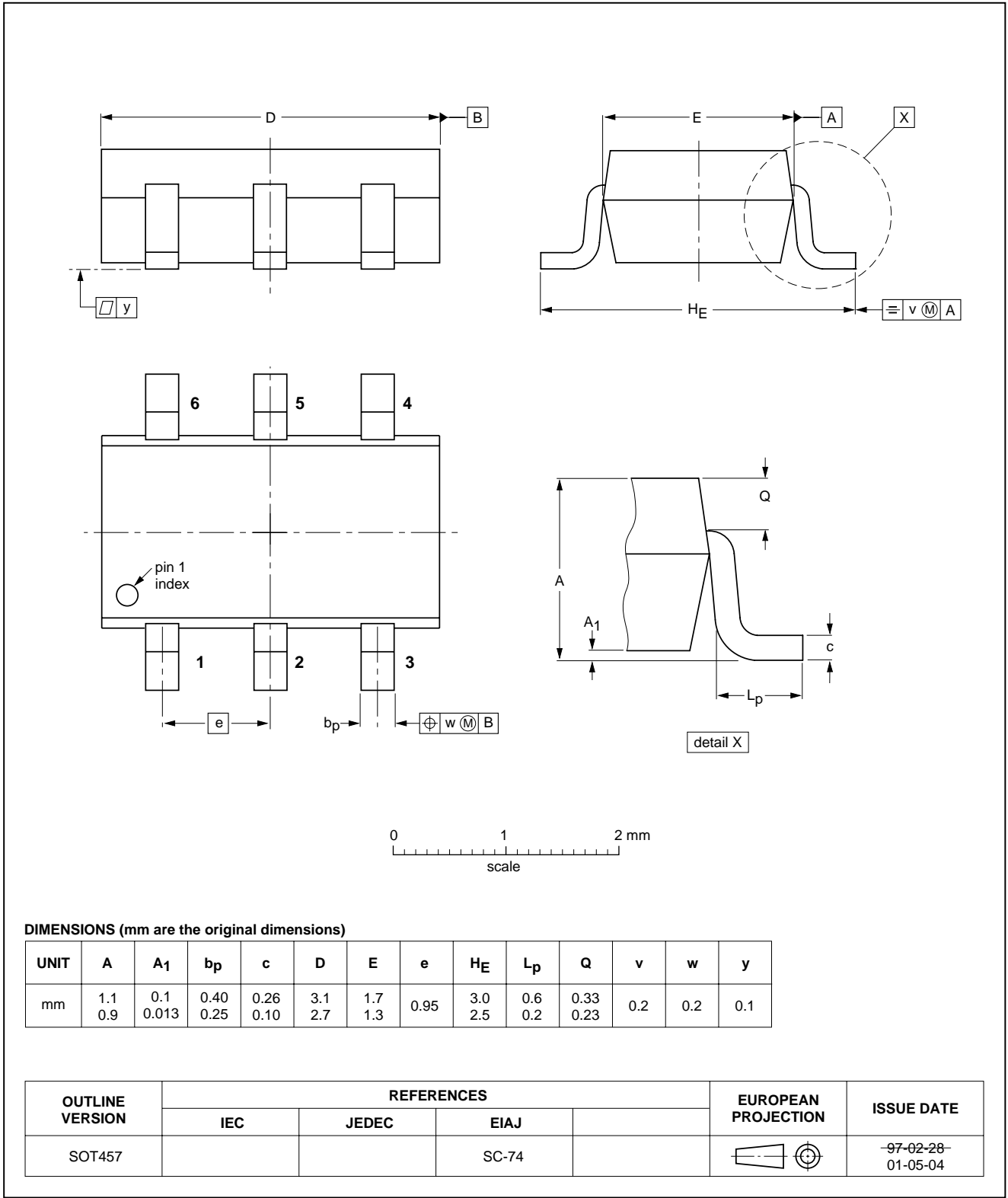
