


 ${\rm V}_{\rm DS}$ - Drain-to-Source Voltage (V)



On-Resistance vs. Drain Current






 $V_{\rm GS}$ - Gate-to-Source Voltage (V)






On-Resistance vs. Junction Temperature







Source-Drain Diode Forward Voltage




Threshold Voltage



On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient










Normalized Thermal Transient Impedance, Junction-to-Ambient
