


E-Series Automotive 650 V, 20 A Silicon Carbide Schottky Diode




Figure 1Forward Characteristics




Figure 2Reverse Characteristics




Figure 3Current Derating




Figure 4Power Derating




Figure 5Total Capacitance vs. Reverse Voltage




Figure 6Capacitace vs. Reverse Voltage




Figure 7Capacitance Stored Energy




Figure 8Non Repetitive Peak Forward Surge Current versus Pulse Duration (sinsusoidal waveform)





Figure 9Transient Thermal Impedance
