








Figure 1. Unclamped Inductive Switching




Figure 2. Switching Time








Figure 3. Diode Reverse Recovery Time






Flow:  $260 \pm 5 \, ^{\circ}\text{C} / 10 \pm 1 \, \text{s}, 2 \, \text{times}$

Soldering should be at a distance of at least 1.5 mm from the body of the product.
