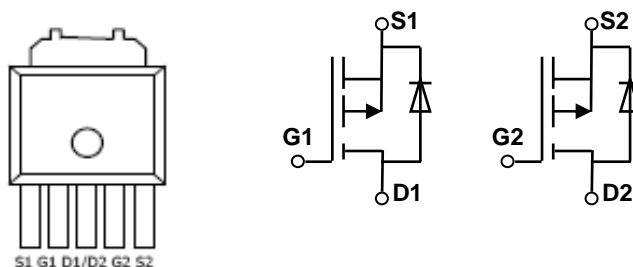

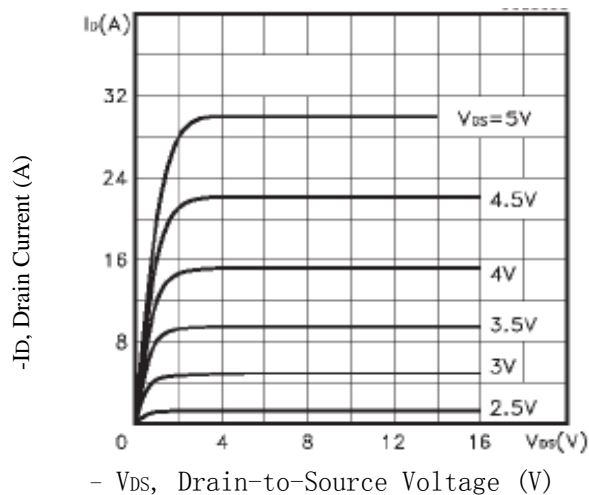


Figure 1. Output Characteristics

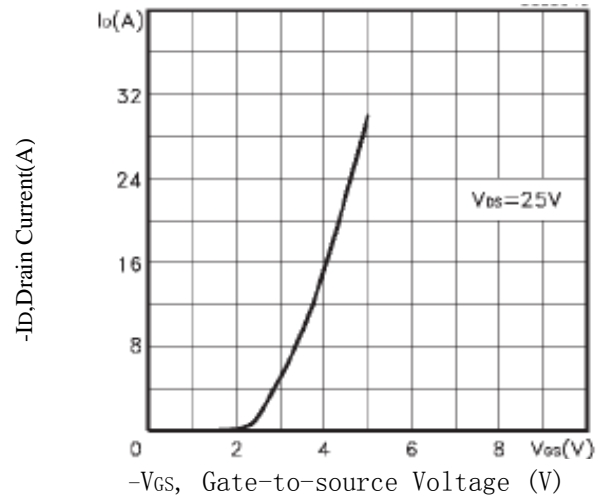


Figure 2. Transfer Characteristics

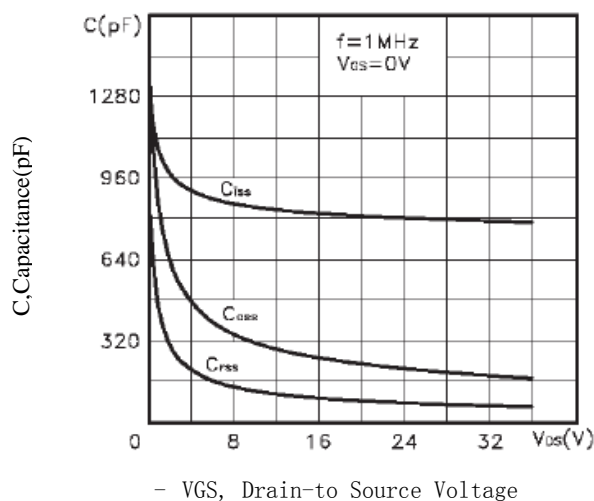


Figure3. Capacitance

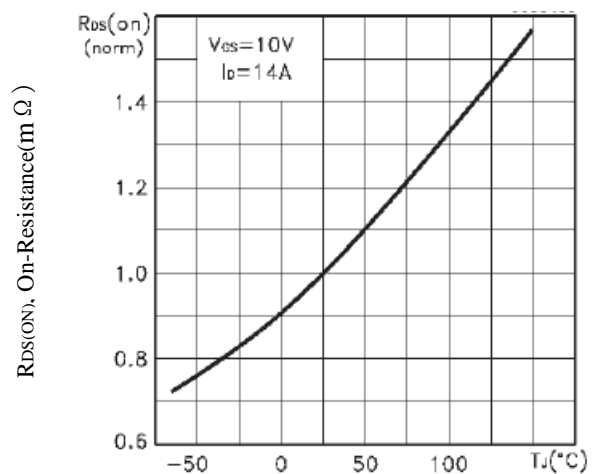


Figure4. On-Resistance Variation with Temperature

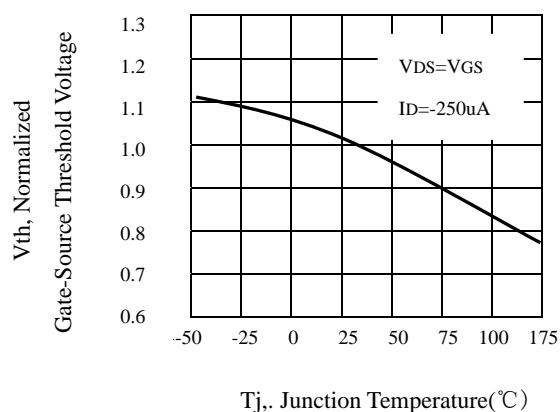


Figure 5. Gate Threshold Variation With Temperature

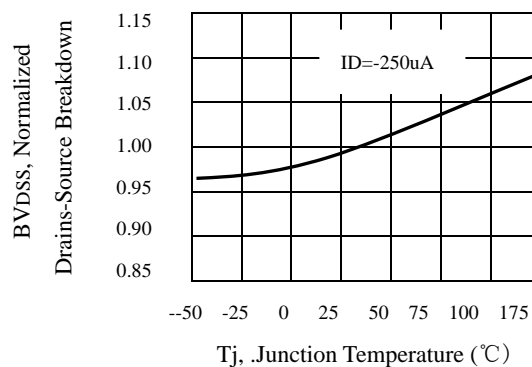


Figure 6. Breakdown Voltage Variation With Temperature

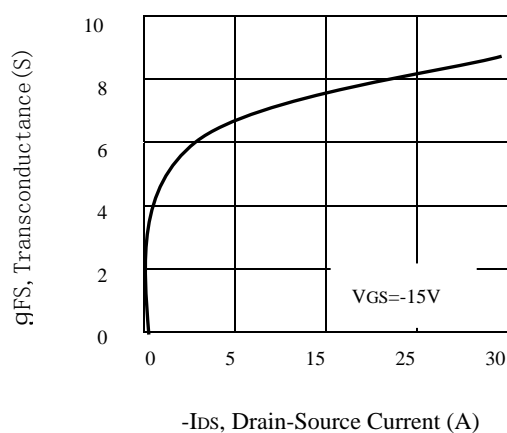


Figure 7. Transconductance Variation With Drain Current

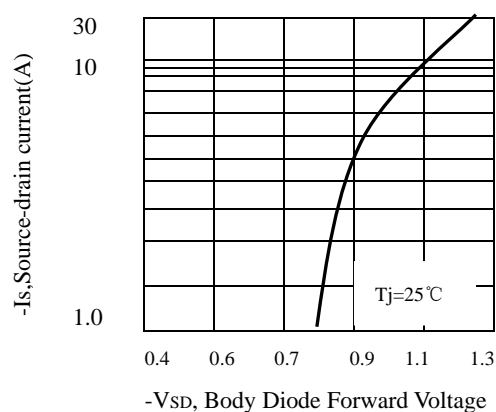


Figure 8. Body Diode Forward Voltage Variation with Source Current

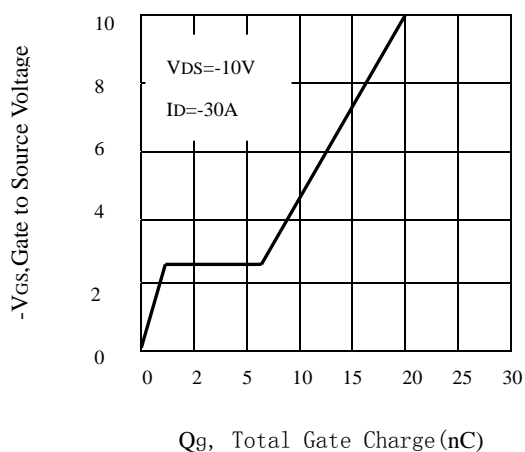


Figure 9. Gate Charge

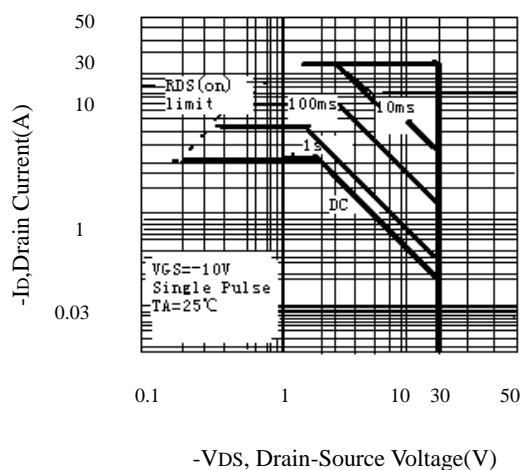


Figure 10. Maximum Safe Operating Area
