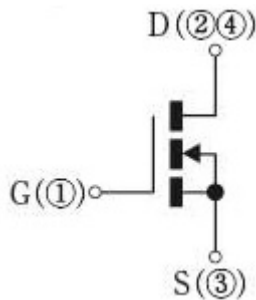

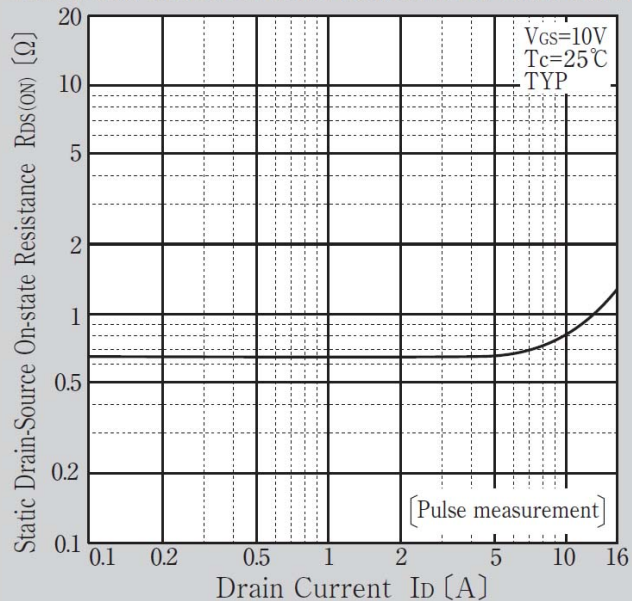

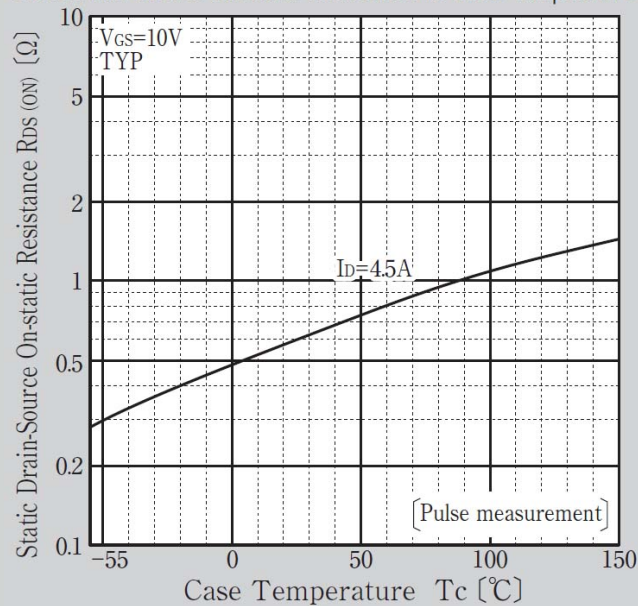

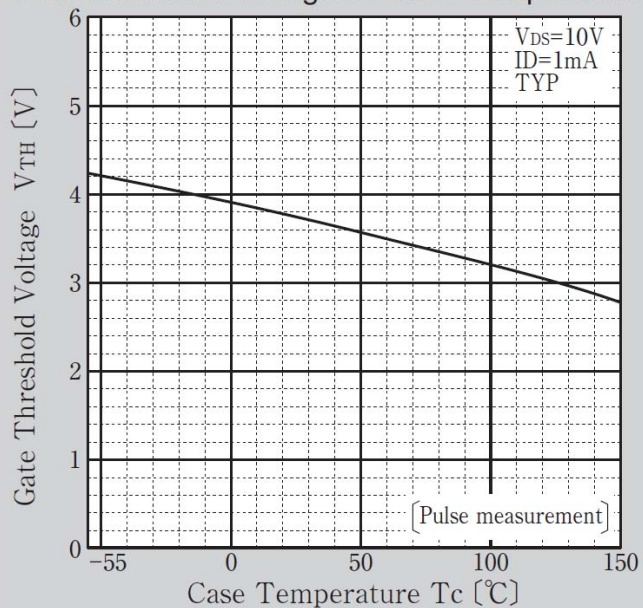
## Static Drain-Source On-static Resistance vs Drain Current



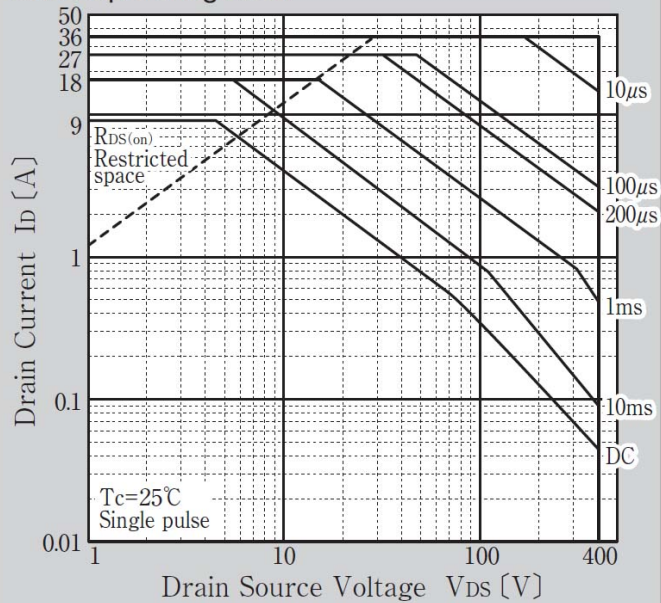
## Static Drain-Source On-static Resistance vs Case Temperature



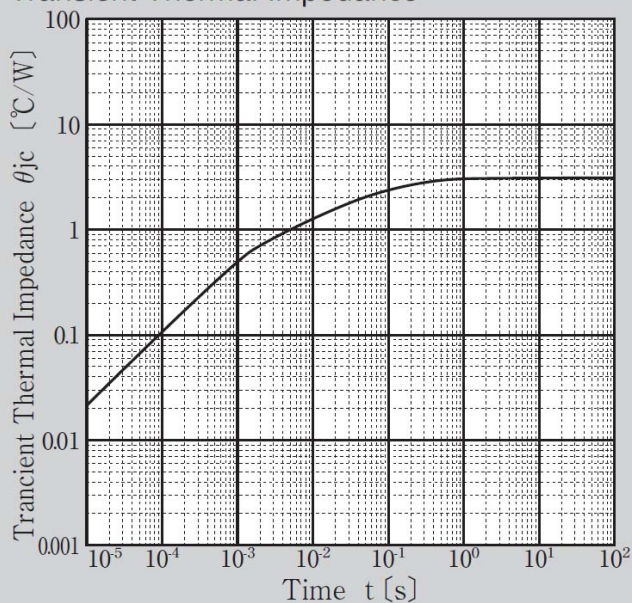
Gate Threshold Voltage vs Case Temperature



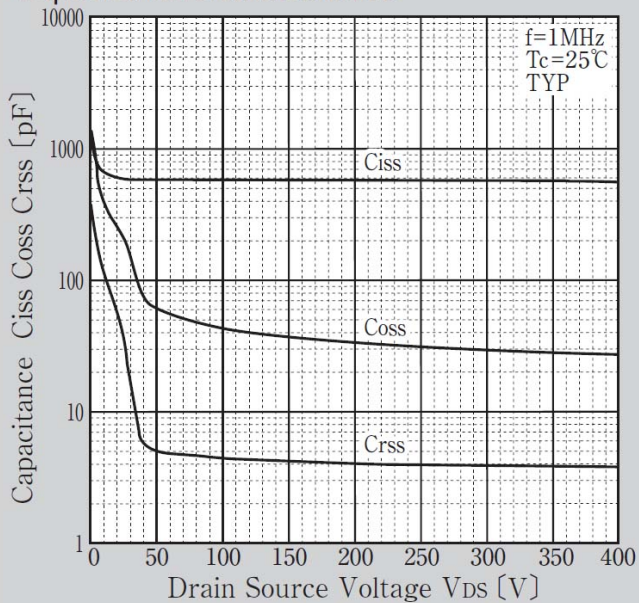
