




fig. 1. Normalized total power dissipation as a function of mounting base temperature





Fig. 2. Continuous drain current as a function of mounting base temperature






Fig. 6. PCB layout with minimum footprint for thermal resistance from junction to ambient







#### N-channel 30 V, 0.82 mΩ, 300 A logic level MOSFET in LFPAK56 using NextPowerS3 technology






