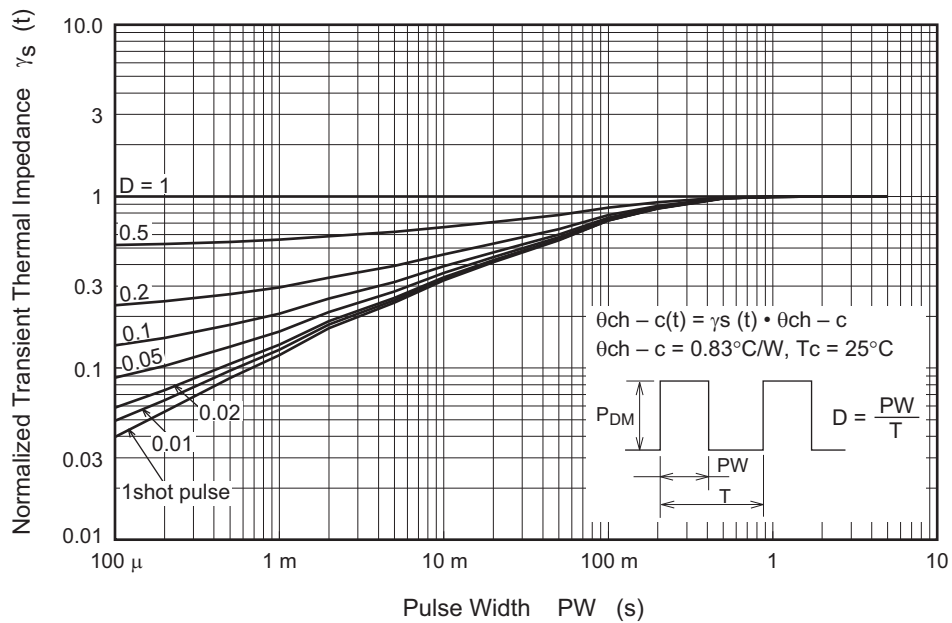


Drain to Source on State Resistance

Drain to Source Voltage

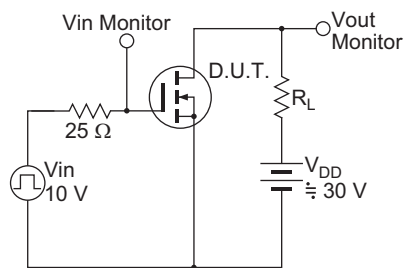

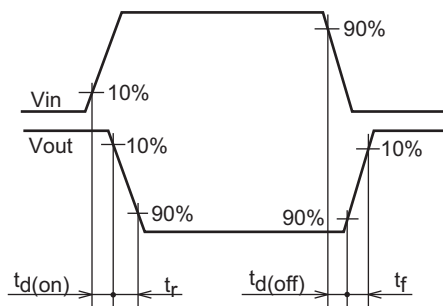
Normalized Transient Thermal Impedance vs. Pulse Width



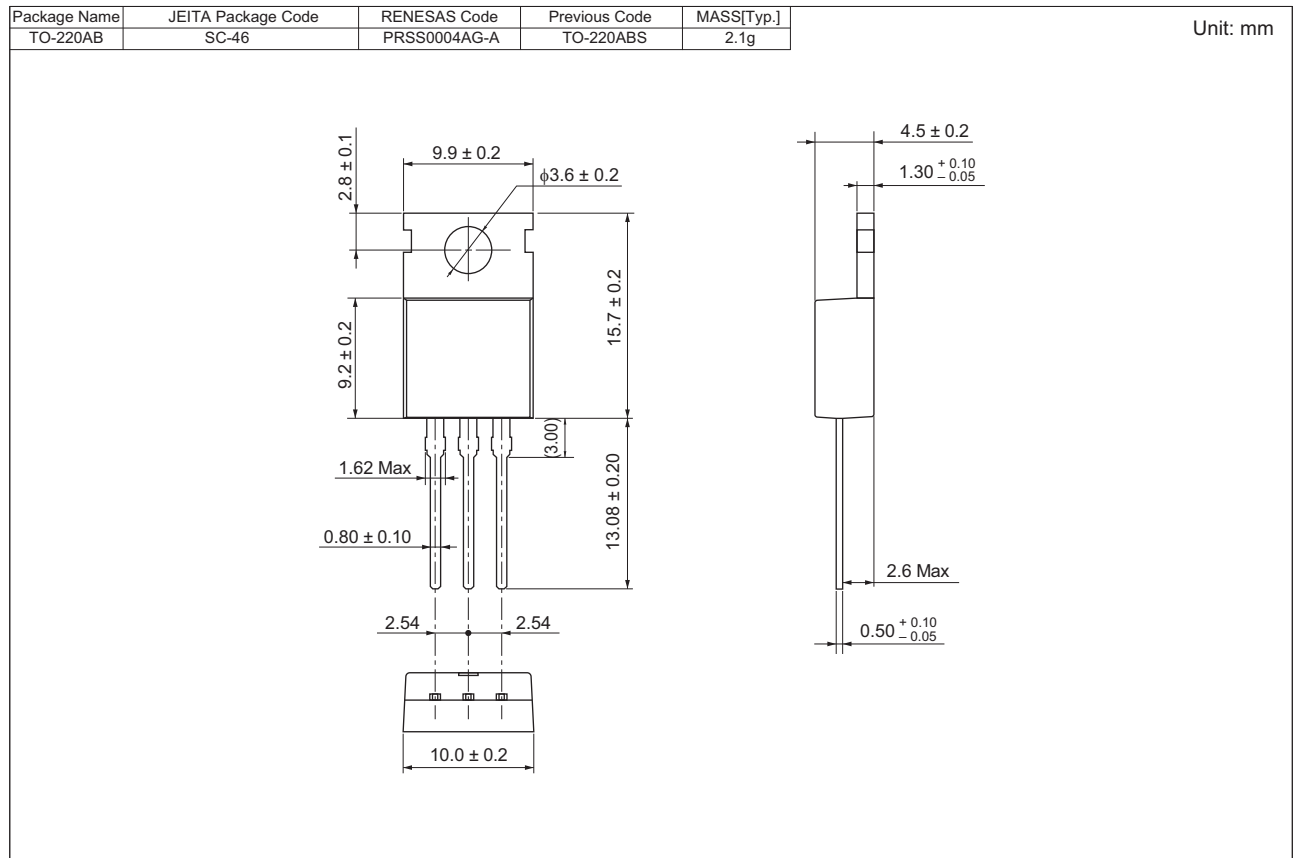
Switching Time Test Circuit
