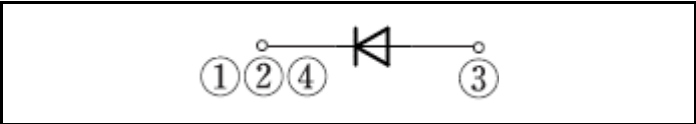

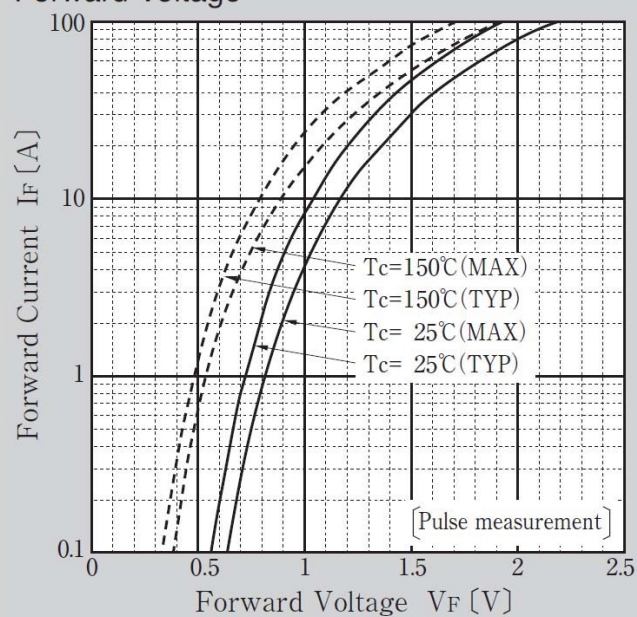

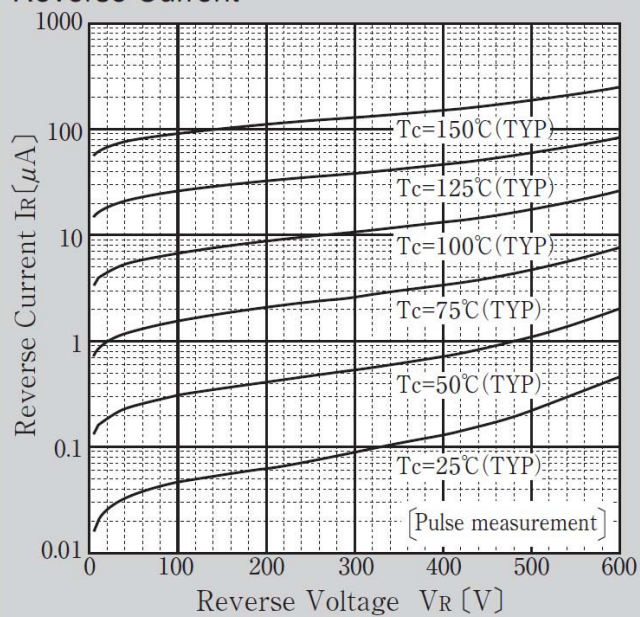

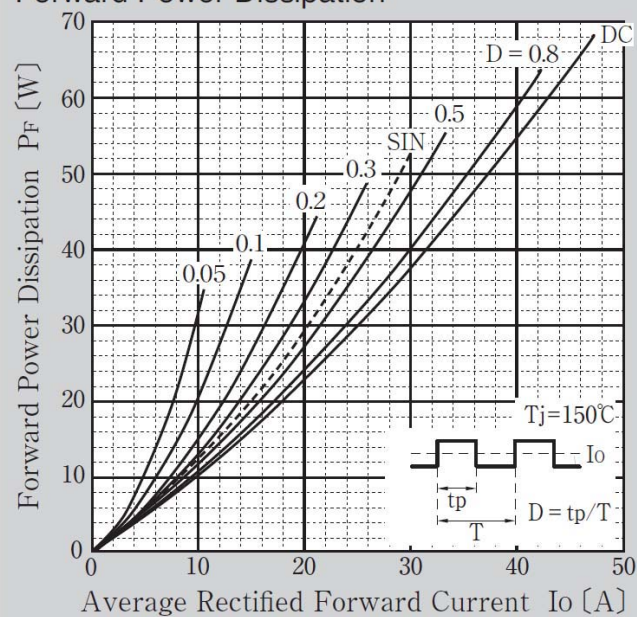
Forward Voltage



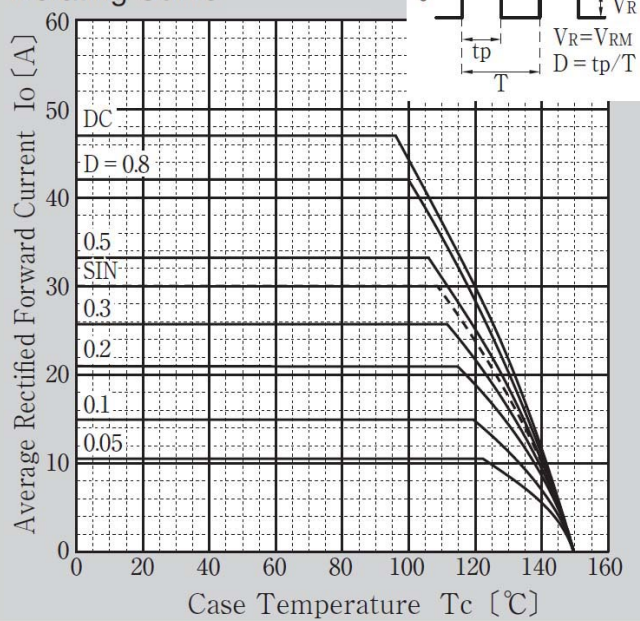
Reverse Current



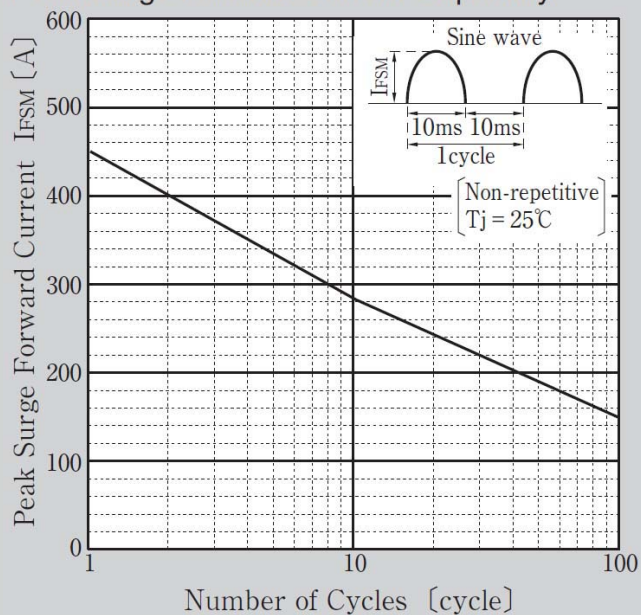
Forward Power Dissipation



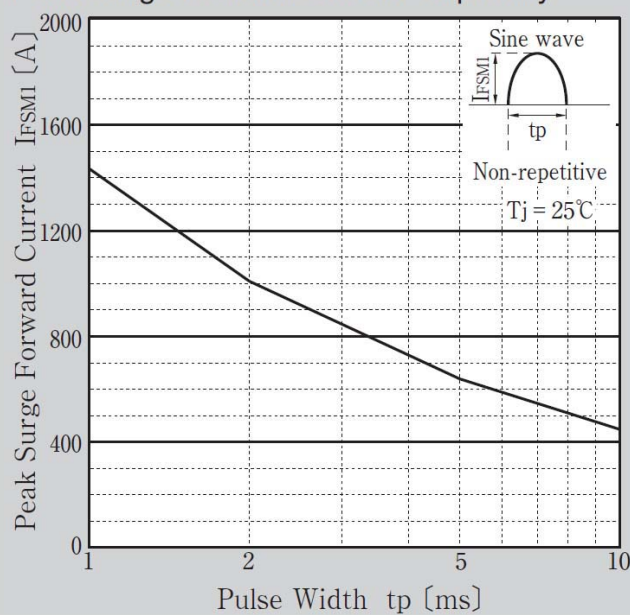
Derating Curve



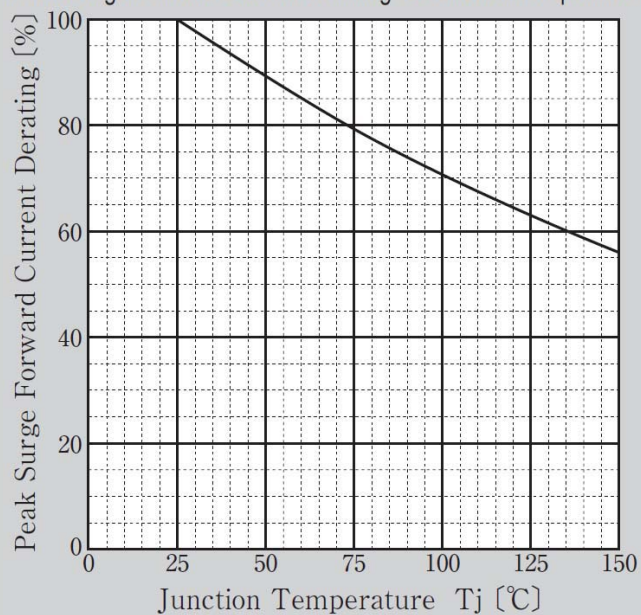
Peak Surge Forward Current Capability



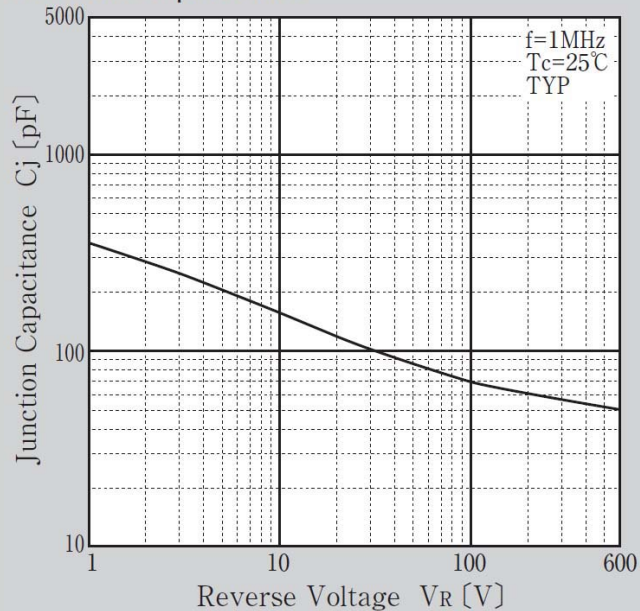
Peak Surge Forward Current Capability



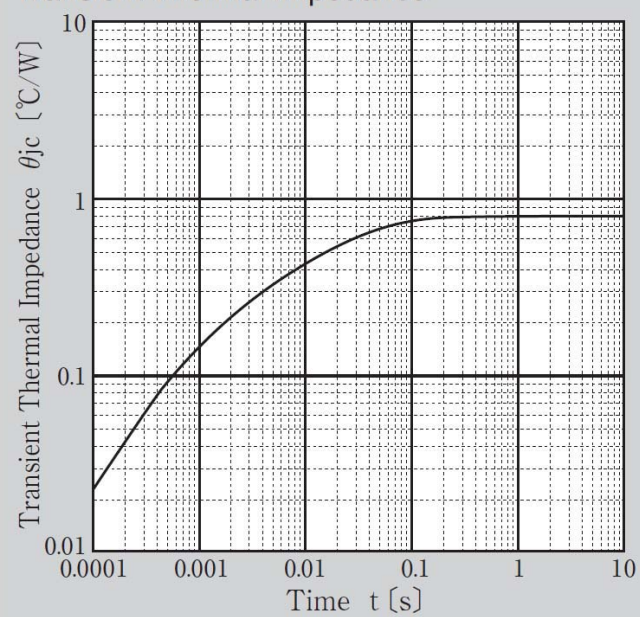
Peak Surge Forward Current Derating vs Junction Temperature



Junction Capacitance

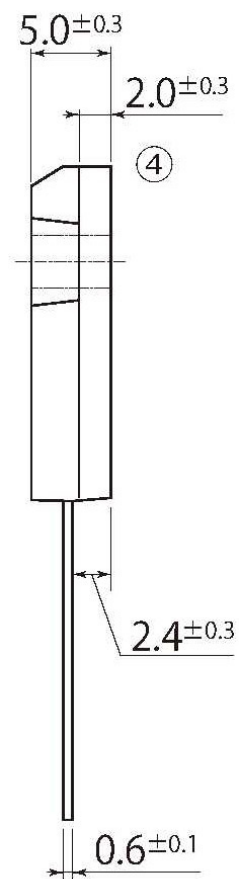
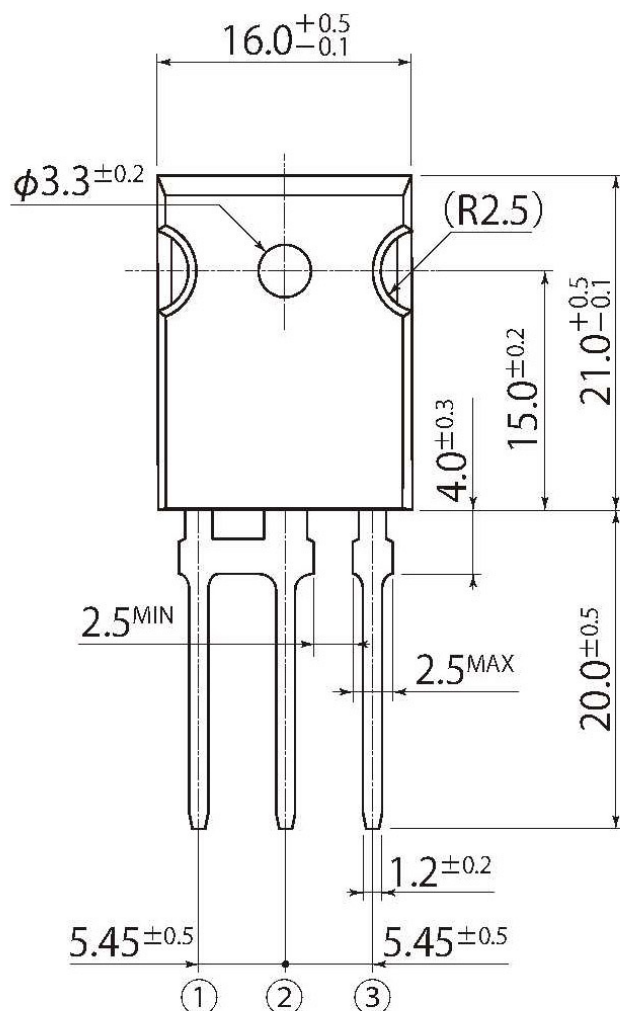


Transient Thermal Impedance
