




On-Resistance vs. Drain Current








On-Resistance vs. Junction Temperature




 $V_{\text{SD}}$  - Source-to-Drain Voltage (V) **Source Drain Diode Forward Voltage** 



**Drain Source Breakdown vs. Junction Temperature** 




On-Resistance vs. Gate-to-Source Voltage






