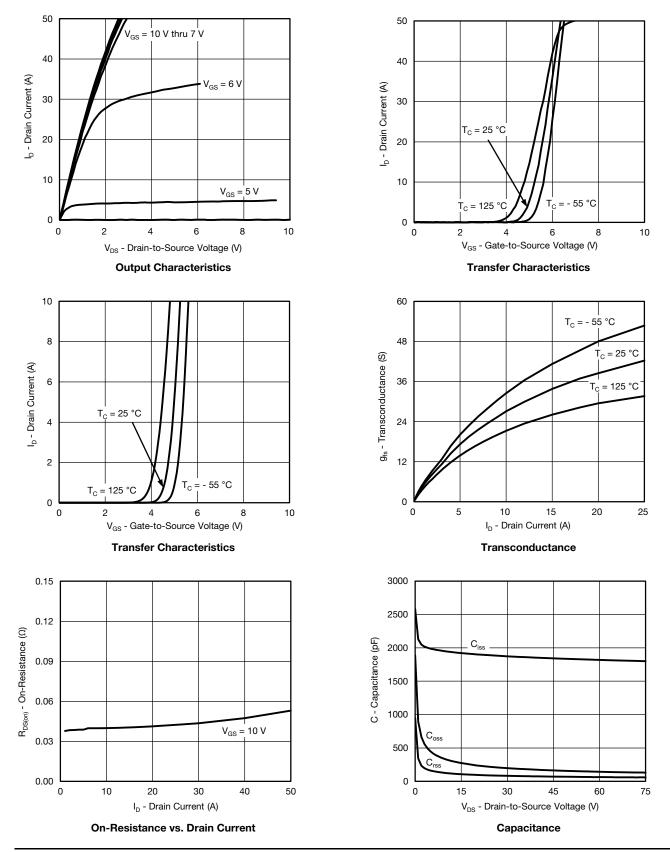

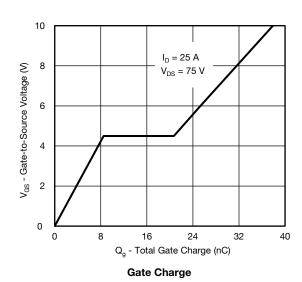

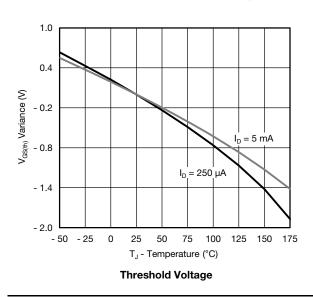


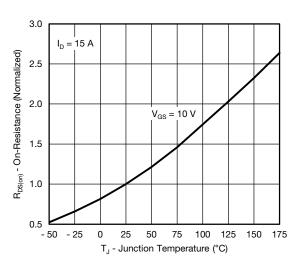

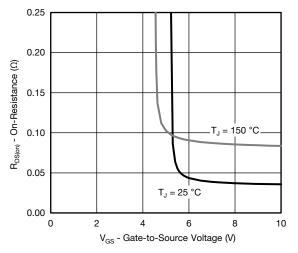


Source Drain Diode Forward Voltage

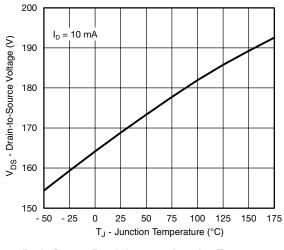




**On-Resistance vs. Junction Temperature**

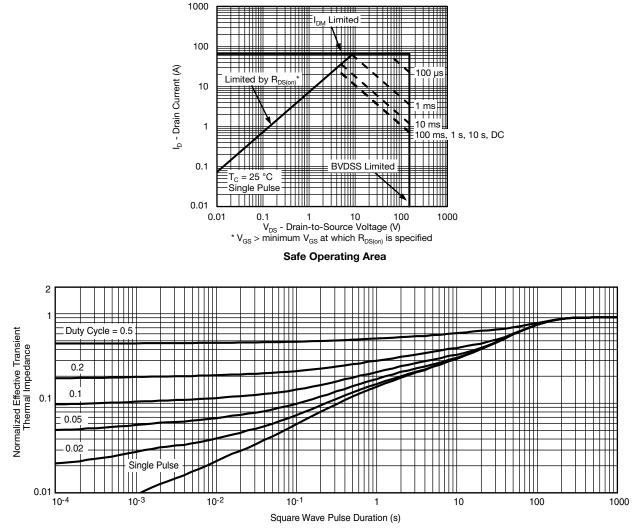

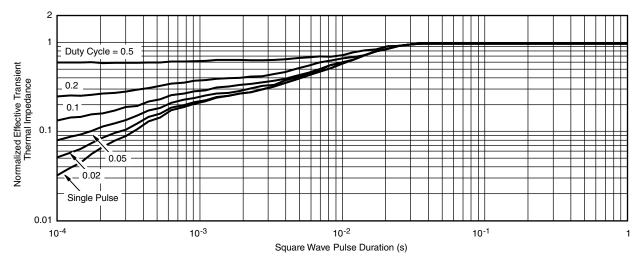
