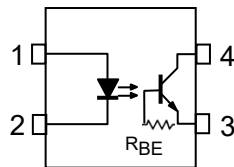

It is generic speed transistor output.

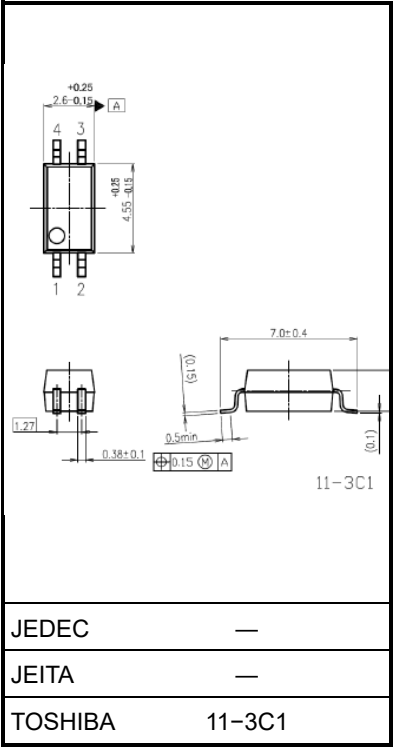

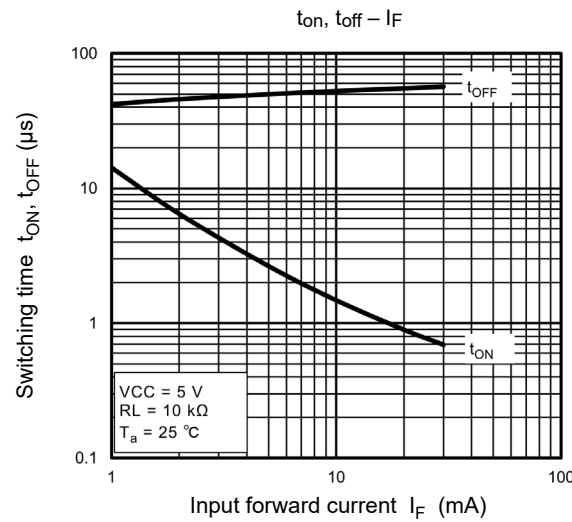
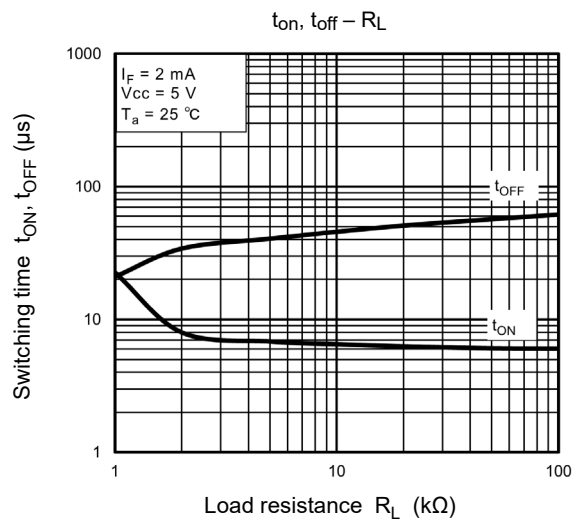
Note 1: Switching time test circuit
