







Fig. 2 - Relative Luminous Intensity vs. Angular Displacement

Fig. 3 - Relative Intensity vs. Wavelength




Fig. 4 - Forward Current vs. Forward Voltage

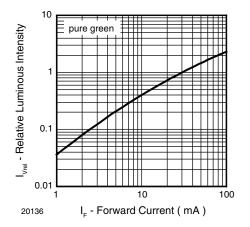


Fig. 5 - Relative Luminous Intensity vs. Forward Current




Fig. 6 - Relative Luminous Intensity vs. Ambient Temperature




Fig. 7 - Change of Dominant Wavelength vs. Ambient Temperature




Fig. 8 - Change of Forward Voltage vs. Ambient Temperature





PACKAGE DIMENSIONS in millimeters








REEL DIMENSIONS in millimeters

TAPE DIMENSIONS in millimeters

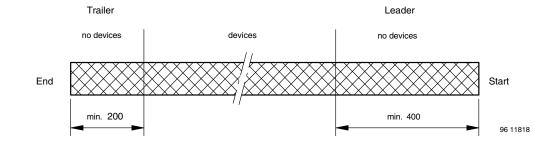





Standard bar code labels for finished goods



The standard packing units are labeled with standard bar code labels before transported as finished goods to warehouses. The labels are on each packing unit and contain Vishay Semiconductor GmbH specific data.

SOLDERING PROFILE







FINAL PACKING

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity \leq 60 % RH max.

After more than 672 h under these conditions moisture content will be too high for reflow soldering.


In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 h at 40 °C + 5 °C / - 0 °C and < 5 % RH (dry air / nitrogen) or

96 h at 60 $^{\circ}\text{C}$ + 5 $^{\circ}\text{C}$ and < 5 % RH for all device containers or

24 h at 100 °C + 5 °C not suitable for reel or tubes.

An EIA JEDEC standard JESD22-A112 level 2a label is included on all dry bags.
