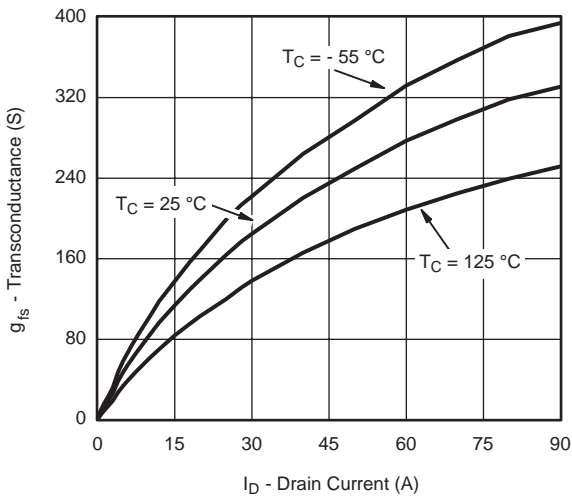

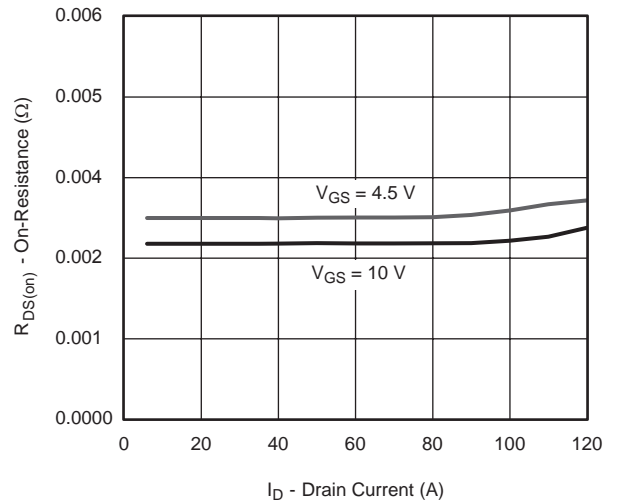

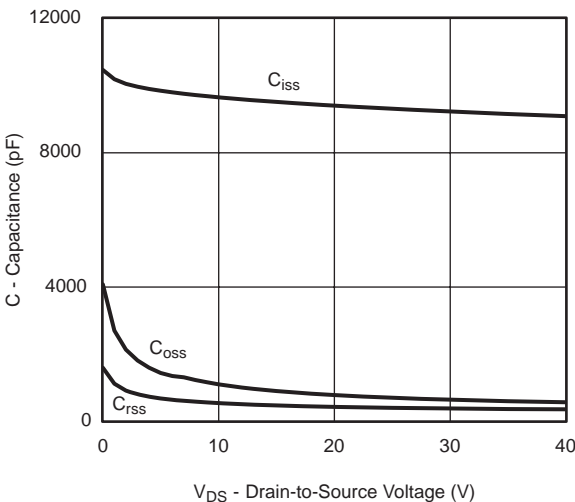

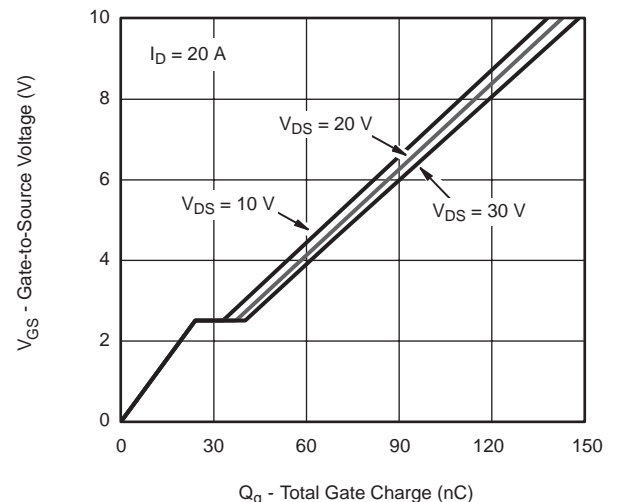
Transconductance

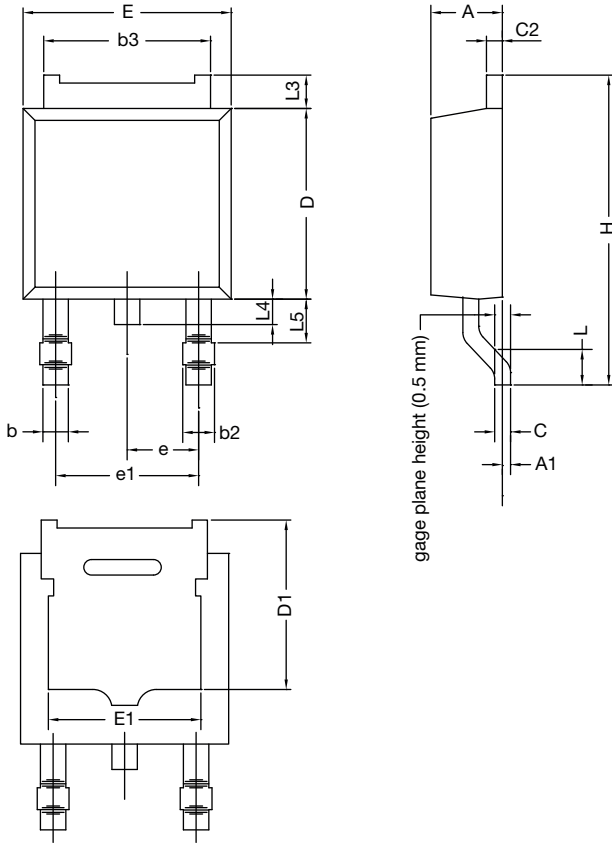
