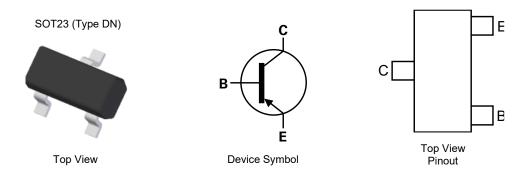

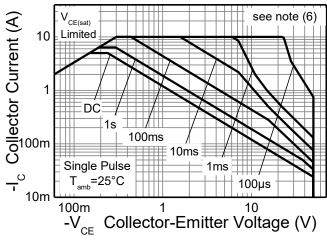


Fig 1. Safe Operating Area

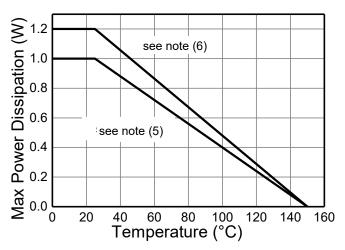


Fig 2. Derating Curve

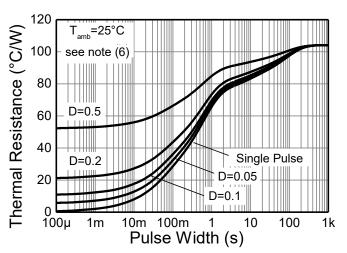


Fig 3. Transient Thermal Impedance

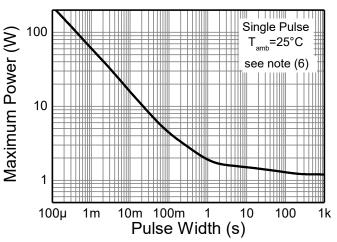


Fig 4. Pulse Power Dissipation
